Depending on the units selected individuals will be able to seek employment not only in rural industries but also other industry sectors, such as local government, tourism, hospitality, transport, construction, information technology and metals.
Entry Requirements	There are no pre-requisite entry requirements for this course of study. Students must undergo a Language, Literacy & Numeracy evaluation prior to commencement of studies
Career Pathway	Further training pathways from this qualification include, but are not limited to, Certificate IV in Agriculture Certificate IV in Production Horticulture or Certificate IV in Horticulture.
