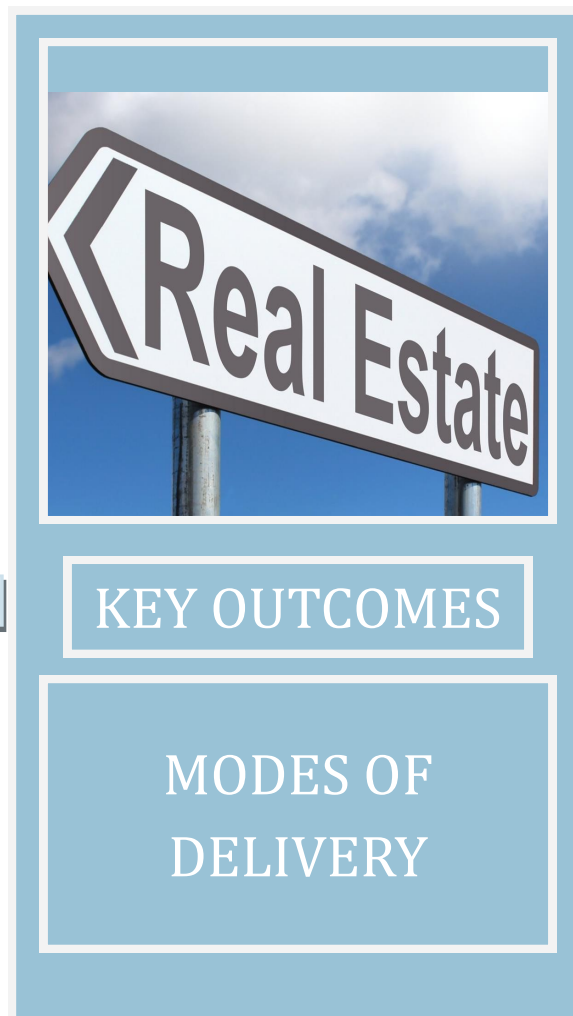
Certificate of Registration– is this for you....

- Anyone who wishes to work in the real estate industry in any capacity under a licensee must hold this: salesperson, stock and station, business, strata, property manager, administration etc.

- Meet the core legal and ethical requirements associated with property management and property sales whilst working ethically and effectively in a real estate agency.
- Source and interpret legislation affecting real estate operations.
- Minimise risk to all aspects of agency business and to consumers including identifying potential risks to the agency and its clients, analysing the causes and potential impact of risks, and implementing agency policies and procedures to minimise risks to the agency and consumers.
- Appraise the sale price range or rental value of all forms of property for listing purposes in line with client instructions, agency practice and legislative requirements.
- Conduct an auction including conducting the auction in line with agency practice, ethical standards and legislative requirements.
- Establish, maintain and expand client-agency relationships to support the attainment of key agency business goals.
- Establish and manage trust accounts in an agency context.
- Administer the leasing of all types of property.
- List and market all types of property and businesses for lease and for sale.
- Manage properties during the term of leases or tenancy agreements including implementing the conditions of leases and tenancy agreements, responding to requests from tenants and landlords and managing the renewal and termination of leases and tenancy agreements.
- Manage effective negotiations in relation to the sale, lease or management of property.
- Prepare for an auction and complete the sale of property.
- Appear effectively before a tribunal including preparing for tribunal hearings, using appropriate tribunal etiquette, acting as a witness, participating in conciliation hearings and presenting a case.
- Sell and finalise the sale of all types of property by private treaty including qualifying buyers, arranging for potential buyers to inspect listed properties, delivering effective sales presentations, submitting offers and negotiating property sale with sellers and buyers and maintaining communications with sellers and prospective buyers.
- Develop and implement a maintenance plan for all types of managed properties including determining property maintenance requirements, establishing a property maintenance plan, establishing and maintaining a key register, monitoring the security of managed properties and implementing and reviewing the property maintenance plan.
- Use communication techniques to manage and resolve conflict and disputes in the property industry
- Manage agency business records and finances
- Determine individual and team development needs and to facilitate the development of the workgroup.

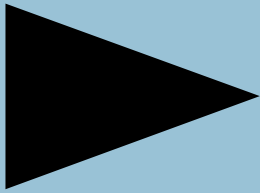
